Key Roles for Parent(s)

Become Informed

Consult and partner with others



## **Become Informed**



Your child's circumstances and what that means for attending in-person schooling

Your state's guidance or rules about school reopening, including any provisions for parental choice in these options

Your district's related guidance or rules

Your rights to participate in education decisions about your child



#### Consult & Partner



What should you be asking for, and of whom?

What are your concerns? They must be included in your child's IEP, if any.

What is the difference between learning at home, home instruction, and home schooling?

Does your child need an Individualized Health Plan if they return to in-person schooling?



## Consult & Partner



What should you do if you are not satisfied with the answers?

Work with your partners to go up the chain of command!

#### **Become Informed**



Your state's guidance or rules about school reopening, including any provisions for parental choice, any special rules for certain populations, and opportunities to provide input and/or feedback

Your district's related guidance or rules about school reopening



#### Consult & Partner



Who to consult/partner with?

Parent organizations

**Advocacy Groups** 

Interested members of the School Board/Board of Education

State, district, and school officials

Health experts and officials



#### Consult & Partner



What are their perspectives?

What information do they have that might inform your thinking?

What information, concerns, and recommendations do you have that might shape their thinking and actions?

What opportunities exist for you to work with them to influence school reopening decisions?



#### Your Plan



What considerations are most important?

Be aware of the full range of issues!

Think of school operations, academic recovery, social-emotional and health supports, remote learning, and family engagement



# Your Plan-State Level



- Work with other advocates and parent leaders
- Targets:
  - State Associations (Principals Association, Superintendents Association, Teachers Union, etc.)
  - State Board of Education
  - State Education Agency Leaders
  - State Legislature
  - Governor



# Your Plan- District/ School Level



Work with other advocates and parent leaders Targets:

- District Board of Education
- Superintendent
- Director of Special Education, Bilingual Education, ESSA/Title I
- Principals



## **Advocacy Goals**



#### Advocate for policies that:

- Ensure access to the best possible education and support services
- Protect health
- Meaningful parent options
- Meaningful family and family organization involvement in decision-making for their own child(ren) and for all children
